





### Fire Department staffing

- □Personnel we are a combination department with full-time and part-time staff
  - ☐ (4) career personnel Chief, Assistant Chief and 2 Firefighters
    - ☐ Career personnel are also certified Code Enforcement Officer or licensed Emergency Medical Service providers
    - ☐ We strive to maintain (2) on duty during the daytime hours of 6am to 6pm.
    - ☐ There are no personnel in the station overnight.
  - □(17)Part-time, on-call Firefighters
  - ■We have adjusted hourly wages in the on-call line to reflect wages in similar communities and to implement a minimum hourly rate per incident
    - ☐ In 2008 this line was \$80,000. It had been steadily reduced reflecting fewer Firefighters responding to incidents.
  - ☐ The numbers of part-time, on-call Firefighters has dwindled in recent years
    - ☐ We are proposing in the EMS portion to provide a stipend for overnight "on-call" pay

## Key Items in the Fire Department budget

- Increasing the part-time line to provide daytime coverage for career shifts
- □ Implementing recommendations from EMS Review
- Emergency Medical first responder program is in process of being licensed by the state
- □Increased maintenance attributed to a Preventive Maintenance program aimed at extending the service life of apparatus
  - $\square$  Need to repair the tank cradle for Engine 5 ( a 1995 truck)
  - ☐ Current replacement cost estimate is \$800,000.00 and 2 years
  - □ Ladder truck is a 1997. Current replacement cost estimate is \$1,250,000.00 and 2 years
- □Review the needs of the public safety building for all 3 services; Police, Fire & EMS
  - ☐ Review space needs for modifications & renovations
    - ☐ Equipment storage, bathroom facilities, overnight accommodations for Fire & EMS

#### FY23 Accomplishments

- Replaced Engine 6 with a new apparatus
- Replaced the pickup with the Ford Lightning (all electric)
- Developed a Preventive Maintenance program & budget for all apparatus
- Implementation of Non-Transporting Emergency Medical First Response Program
  - On-going Educational process for the program and personnel
  - Hopeful to implement the recommendation to include personnel from the 4 towns



### The past meeting the future

Fire Chief Alan Payson started an emergency medical services response program in the 1940s. The Department is back to fulfilling aspects of that service.

Continuing to work with Camden Hills State Park staff and Coastal Mountain Search & Rescue to fulfill needs in the outdoor recreational areas.

Working with State Park staff on grants to obtain UTV and equipment to use in the Park.

This collaborative effort is transferable to the Ragged Mountain Recreation area.



## Planning for the future

Working with the Police Department to review the needs & function of the existing public safety building.

Working with our Mutual Aid partners to continue implementing recommendations from the EMS review.

Working with all Fire & EMS agencies in Knox County to review our current status and provide recommendations moving forward.
