The Friends of Tannery Park is a community-based group of committed and energetic citizens of Camden, who have been working since August of 2014 to create an official Town of Camden Park on the site of the former Apollo Tannery. The Friends of Tannery Park has currently 240 members who have been working the last six years through a community process, to achieve the final goal of establishing a multi-use community park.

We believe Tannery Park can become a source of genuine community pride. We are dedicated to the achievement of an improved Tannery Property that benefits a broad segment of the Camden community. We believe in a pragmatic, phased approach to the site that increases the prospect of successful completion and avoids contentious neighborhood or community opposition.

Overview

The Friends of Tannery Park is submitting this community-based proposal. This proposal is inspired by the findings of Camden's Tannery Work Group that met for over two years with three community-wide meetings. The Tannery Work Group reached a consensus on a framework that could guide the Town to achieving the final goal of a multi-use Town Park.

This proposal is designed to provide additional community assets to the residents of Camden on a reasonable scale while serving a wide multi-age, cross-section of the Camden Community. If this proposal is adopted, Camden will benefit by the preservation of Tannery Park with its current popular uses and allow for the addition of new recreational facilities in walking distance of village neighborhoods. It will guarantee a permanent home for The Camden Farmers' Market and it will also provide additional affordable housing thru Midcoast Habitat for Humanities.

Major Elements of the proposal:

- The Friends of Tannery Park is proposing that the Town of Camden will retain ownership of the former Apollo Tannery Site, now known as "Tannery Park" to be designated as an official Town Park. The Park will provide a multi-use community space that can offer many recreational, social, and educational, uses to the citizens of Camden (list to follow below). Future additions to the Park will be built in a phased sequence over time as fundraising goals are achieved for each new feature. Donations will be sought thru individuals, businesses, and grants. In addition, the Town received a \$200,00 EPA environmental remediation grant that can be applied to costs for some of the groundwork.
- 2. The Friends of Tannery Park is proposing The Camden Farmers' Market as a collaborative partner in this proposal. They will separately negotiate a multi-year lease with the Town of Camden for their Saturday and Wednesday markets. Their presence at Tannery Park for the last three years has proved to be a great success for the Farmers and the community as a whole. The Saturday Camden Farmers' Market has become a huge community gathering spot. (See the attached Letter of Support from "The Camden Farmers' Market")
- The Friends of Tannery Park is proposing Midcoast Habitat for Humanity as a collaborative partner in this proposal, to be sold an appropriate amount of space for two to three affordable homes. The space designated would be adjoining the existing homes along the Washington St frontage.

Midcoast Habitat for Humanity will administer the building, marketing, and sale of the homes following their time-proven formula for providing affordable homes that fit into existing neighborhoods.

(Midcoast Habitat for Humanity will be submitting their proposal for their homes separately.)

Sources of Funding for Park Improvements

1. Epa grant

The Town received a \$200,000 grant fom the EPA for additional remediation. These funds will contribute to transforming areas of the site such as the old foundation and the broken asphalt into a clean canvas for implementing future features of the Park.

2. Fundraising

Community Fundraising builds a stronger community!

Many fundraising strategies are available for community fundraising for Park improvements. They include:

- a. Fundraising Events- concerts, garage sales, raffles, auctions
- b. Online Fundraising-"Go Fund Me" app- for specific features
- c. Appeals to individuals and local foundations to adopt specific Park features.
- d. Seeking involvement of local service organizations, such as Rotary, and Lions club for funds and community labor.

3. Grants

Numerous grants are available to fund Park and Recreation facilities for towns such as Camden.(See the Appendix for a list of current possibilities)


I write to you today as a neighbor of Tannery Park and as a member of the Tannery Work Group. I completely support the proposal of the Friends of Tannery Park.

We are writing as Camden residents in support of the Community Park Proposal being made in response to the RFP regarding the Tannery site on Washington Street Camden.

Is Camden trying to attract young families, as the state of Maine is? Maine is the oldest state in the nation, with a median age of 44.6. If Camden is interested in having young families move to our town, or interested in keeping the young families already here, the Tannery site is an important opportunity to create a space that will help attract and retain young families.

Community recreation programs and parks provide a place for social equity, ensuring that all citizens have access and the opportunity to benefit without financial or social barriers. Public commons are often the glue that brings and holds a community together.

Sure, the "bottom line" (profits) may be top-of-mind for town and business leaders, but evidence also suggests that companies are placing importance on recreational opportunities for their workers' families. Today's business leaders seek availability of outdoor activities to enhance the quality of life for their employees when they are deciding where to open a shop or move their operations. Bottom line, parks are a good financial investment for a community.

Clemson and North Carolina State researchers have shown that parks and greenways can play an important role in reducing rates of violent, disorderly and property crimes. Additionally, communities that keep basketball courts open late for "Midnight Basketball" programs experience a reduction in youth crime rates.

Numerous studies show how valuable green spaces are for reducing stress and increasing happiness. Even just 10 minutes spent reading or contemplating in a park enhances your sense of wellness, lowers the stress hormone cortisol and strengthens your immune system. Playgrounds provide multi sensory experiences that help children's brains develop in a healthy way. Kids can learn and challenge different parts of their brain and body such as sensory (visual, auditory, tactile, vestibular), motor (hands and fingers, agility, balance, endurance, muscle coordination, eye-hand coordination, while developing strength and cognitive abilities in problem solving, strategic planning, and literacy.

A public green space with playground creates opportunities for parents to bond with children and with each other in an equitable and physically engaging way that shared digital or TV time does not. Play teaches children social skills: how to share fairly, to play cooperatively, and to collaborate as part of a group.

Our Camden communities are desperate for public open space. With the exception of one swing set at Laite Beach, there are no public playgrounds available during the day anywhere in our town. Where does a grandparent take their grandchild for a safe, free, and healthy outing? As you consider the highest and best use of this town owned property, please put an appropriate value on the health and well-being of our young people and families. They are our town's future. Let's not sell them short.



All these activities point to a real demand for what this property can offer. Imagine what a resource this land could be with just modest improvements, as envisioned by the Friends of Tannery Park plan.

This plan provides a long-term home for the Camden Farmer's Market, which we strongly support. The market is a great resource for this community and will be well served by the stability this plan will afford, as well as the more inviting surroundings. It is great to think there will be a place for children to play while their parents shop and visit with their neighbors at the market.

We thank the Friends of Tannery Park for their hard work on this proposal and give it our hearty endorsement.

However, their considerable commitment and investment of volunteer time was to no avail, evidently, since although their report was accepted, there was no movement by the town to adopt any of its recommendations. (Except that the Camden Farmers Market was permitted to continue to use the space on a somewhat provisional basis.)

Around this time, the town experienced a change in administration, with a new town manager and a new planner/development director coming on board, both of whom had their own ideas and, perhaps, did not feel obligated to honor the efforts of the Tannery Work Group and townspeople and to carry forward and implement the Group's recommendations. This coincided with a major turnover in members of the Selectboard.

The entire process stalled again. Still, the townspeople had no park. Meanwhile, it was found that the "cheap" environmental solution the town administration and CEDAC (the economic development committee) recommended to mitigate environmental toxins, and that townspeople voted to implement so many years ago, was not a very smart solution after all; considerable environmental issues remained still to be treated and mitigated.

Has anyone thought to add up the amount of taxpayer dollars and residents' volunteer time in the past, say, fifteen years that has been devoted to this small little space within the village? That figure would be instructive. At this point, it must be the most expensive little piece of property in Camden, if not Knox County, and with very little to show for it, except disappointed people.

It is time for this devotion to a vision (a community park) that townspeople have sustained and worked on year, after year, after year to be honored. *Their commitment*, the commitment of people who actually live and work in the community who have sustained and worked on bringing this dream to reality deserves to inform the decision.

Therefore, we urge support for the TANNERY PARK COMMUNITY PROPOSAL submitted by the FRIENDS OF TANNERY PARK, a coalition of Camden residents who have advocated for a community solution -- a park -- for more than a decade. They have put together a beautiful proposal, partnering with Mid-Coast Habitat for Humanity and the Camden Farmers Market. It incorporates many aspects, including a wildflower meadow to enhance the Megunticook Riverwalk and protect the Megunticook River from polluted run-off, a multi-use recreational and educational space, and two to three units of affordable housing.

This is the "community proposal," with emphasis on the word COMMUNITY, and it should be accepted. It is OUR community and OUR residents who should benefit from the major investment we have all made in terms of taxpayer dollars, time, caring, and itment. It would be unconscionable if any other entity, in particular a private develo, e to benefit from our efforts.

Why Parks and Recreation are Essential Public Services

Parks and recreation have three values that make them essential services to communities:

- 1. Economic value
- 2. Health and Environmental benefits
- 3. Social importance

Just as water, sewer, and public safety are considered essential public services, parks are vitally important to establishing and maintaining the quality of life in a community, ensuring the health of families and youth, and contributing to the economic and environmental well-being of a community and a region.

There are no communities that pride themselves on their quality of life, promote themselves as a desirable location for businesses to relocate, or maintain that they are environmental stewards of their natural resources, without such communities having a robust, active system of parks and recreation programs for public use and enjoyment.

Economic Value

- Parks improve the local tax base and increase property values. It is proven that private property values increase the value of privately owned land the closer such land is to parks. This increase in private property value due to the proximity to parks increases property tax revenues and improves local economies.
- A Texas A&M review of 25 studies investigating whether parks and open space contributed positively to the property values of surrounding properties found that 20 of the 25 studies found that property values were higher. "The real estate market consistently demonstrates that many people are willing to pay a larger amount for property located close to parks and open space areas than for a home that does not offer this amenity,"
- American Forests, a national conservation organization that promotes forestry, estimates that trees in cities save \$400 billion in storm water retention facility costs.
- Quality parks and recreation are cited as one of the top three reasons that business cite in relocation decisions in a number of studies.

- Parks and recreation programs provide places for health and well-being that are accessible by persons of all ages and abilities, especially to those with disabilities.
- In a 2007 survey of Fairfax County, VA, residents of 8 of 10 households rated a quality park system either very important or extremely important to their quality of life.
- Research by the Project on Human Development in Chicago Neighborhoods indicates that community involvement in neighborhood parks is associated with lower levels of crime and vandalism
- Access to parks and recreation opportunities has been strongly linked to reductions in crime and to reduced juvenile delinquency.
- Parks have a value to communities that transcend the amount of dollars invested or the revenues gained from fees. Parks provide a sense of public pride and cohesion to every community.
