### Public Hearing #1:

- Amend Chapter 290, Article X Performance Standards, § 290-10.2 Shoreland Areas, I. (1) General Standards and J. Piers to further regulate piers.
- Amend Chapter 290, Article XII, Site Plan Review, § 290-12.6 Approval Criteria J. Special criteria for piers and other structures or uses adjacent to or projecting into water."..., (1)-(7).

- Amend Chapter 290, Article XA, § 290 10A.5, Off-street parking and loading standards- exempting accessory apartments from parking requirements, to comply with state law.
