Bids not dated and time stamped by the Office of the Town Manager prior to the specified date and time stated above will be returned unopened.
  
- 3. BID AWARD:** Bid award, if the Town determines to award, will be made within thirty (30) calendar days after bid opening, to the bidder whose bid fully complies with the requirements specified. The Town reserves the right to reject any and/or all bids without absorbing any liability against the Town.
