- Minutes from April were not approved due to their late delivery. Approval tabled to the next meeting in June.
- MCHT – requested to meet with us to discuss the possibility of collaborating. They also suggested including the Georges River Land Trust and other local orgs interested in discussing future plans for trails and pathways in the area. **Lynda – Action** invite to July 1 meeting in Camden
- The next regularly scheduled meeting conflicts with the next library community input meeting. Next monthly meeting rescheduled to Monday, Jun 1. **Action Geoff** to check on room in Rockport with Stacey.
- The group discussed the idea of a formal Ribbon Cutting for completion of the Tannery section of the Riverwalk. **Action - Eliza, Wyatt, and Owen** will start brainstorming.
- RTP for construction of Seabright phase of the Riverwalk. **Action - Geoff** to check in with Landon on engineering design payment. Are there no RTP funds?
- Rockport Bike/Ped Master Plan – the Committee worked on priorities for future construction. **Action Geoff** to send Lynda a summary. Lynda will incorporate and distribute to everyone her latest draft. Following is that summary as recorded:

High

- Route 1
An extension of the existing sidewalk along the south side of outer Elm Street (in Camden) from Camden Street to the traffic signal at Hannaford's, to the Concord Trailways Bus Depot (Maritime Farms gas station) and beyond to connect to Country Way allowing access to the hotel, the Emporium (30 Commercial St) and restaurant south of the gas station. Continuing on to 56 Commercial St (Leonard's). This includes a crosswalk at Camden Street and a Pedestrian crossing signal at the Hannaford's intersection.
- Rt 90
 - Phase I: West Street - extend existing sidewalk to Rte 1
 - Phase II: extend sidewalk from Rte 1 to CHRHS
 - Phase III: pedestrian crossing at Rte 1

Medium

- Warrenton
Extend existing sidewalk to Eastward; have a path across Eastward property; sidewalk/path from Eastward to Samoset driveway (across Samoset property)
- Rte 1
Construct a sidewalk from 56 Commercial St (Leonard's) to Rte 90
- Russell Ave
 - Extend sidewalk – Calderwood to existing Camden sidewalk on Chestnut
 - Construct sidewalk to Camden town line
- Construct a multi-use pathway from CHRHS to CRMS

Low

- Rt 90
 - Phase IV: extend sidewalk from CHRHS to West Rockport
 - Phase V: pedestrian controlled crossing across Rt 90, somewhere from CHRHS to Erickson Farm.
- Erickson Farm to Beech Hill Preserve connection
- Rockville Sidewalk
- Main St
Extend sidewalk from Summer St to Town office
- Rte 1
Connect sidewalk from Warrenton to Rockland Town line where there is an existing sidewalk.
- Limerock
Remove existing sidewalk at library
- Construct a Lilly Pond Loop
- Construct a Shore Trail from the Harkness Preserve to Glen Cove

- Route 1 - Construct a multi-use pathway to Rockland
